



The plant is in a strategic position along the route A26, just few kilometers away from Turin area. It has an extension of 6,500 sqm.

The site is authorized to treat 82,000 tons per year of industrial waste, with both disposal and recovery processes, allowing the application of modern circular economy techniques. The plant can receive liquid, sludgy and solid waste.
